PUBLIC COMMENTS - NONE

a) Consideration with action of Proposed Tax Rate Calculations for 2021 – Mr. Ernest Garza updated members of the calculations. He advised them that proposed No New Revenue (NNR) rate of \$0.744060 would bring in an additional \$19,654 tax levy increase from last year. The total proposed tax levy would be \$659,599. This would \$.03 less than last year rate of \$0.773931. Motion was made by Mayor Pro-Tem Reyes to approve Proposed New Revenue rate of \$0.744060. Motion was seconded by Alderman Hernandez. Motion carried with all ayes and 0 nays.
